Police Officer Jeff Atherly was shot and killed while checking on a suspicious vehicle in a grocery store parking lot, on the 1400 block of SW Huntoon Street, shortly after 6:00 pm.

Several minutes after making contact with multiple subjects in the vehicle, one of them opened fire, fatally wounding Officer Atherly and Corporal David Gogian. A third officer on the scene was not wounded. The subject who opened fire fled in the vehicle. He was located in a home on Third Street where he barricaded himself for several hours. He was eventually shot and killed after exiting the home while carrying a firearm.

Officer Atherly had served with the Topeka Police Department for just under two years. He is survived by his two children.

Corporal David Gogian was shot and killed while checking on a suspicious vehicle in a grocery store parking lot, on the 1400 block of SW Huntoon Street, shortly after 6:00 pm.

Several minutes after making contact the multiple subjects in the vehicle, one of them opened fire, fatally wounding Corporal Gogian and Officer Jeff Atherly. A third officer on the scene was not wounded. The subject who opened fire fled in the vehicle. He was located in a home on Third Street where he barricaded himself for several hours. He was eventually shot and killed after exiting the home while carrying a firearm.

Corproal Gogian was a U.S. military veteran and had served with the Topeka Police Department for eight years. He is survived by his wife and four children.

Use of Criminal Justice Data

The following should be considered when using the data contained in this publication:

- The data contained herein is from agencies that submit incident based data to the Kansas Bureau of Investigation (KBI). It does not include some of the larger agencies in the state that only submit summary data.
- This data should be viewed as a snapshot of crime in Kansas. These numbers constantly change as some crimes are not reported until years later. The data contained in this publication reflects reports in our system on 10/1/2013.
- Due to staffing and budgetary constraints, November and December data for 2009 is incomplete. Most violent, sexual and domestic violence crimes were entered, but many property crimes were not. This may account for a decline in some crimes at the end of 2009.
- Person crimes (murder, rape, aggravated assault) are scored as one offense for each victim. Property crimes (burglary, larceny, robbery and arsons) are scored as one offense for each incident.
- When discussing arrest data there is a difference between persons arrested and incidents cleared by an arrest. For clearance purposes, only one arrest is counted for each incident.
- Property value data reported with burglary offenses are also included in data reported for theft/larceny offenses.
- When more than one type of theft occur within an incident, the type which incurred the highest dollar loss is reported and all property stolen included.

History of Kansas Incident Based Reporting

The collection of crime data in Kansas began in the mid-1970's after legislation was passed (Kansas State Statutes 21-2501a and 21-2504) authorizing the Attorney General to collect information necessary to determine the true condition of crime in Kansas. The Attorney General assigned the Kansas Bureau of Investigation (KBI) to establish a statewide program for the collection of Uniform Crime Reporting (UCR) data for submission to the Federal Bureau of Investigation (FBI). Subsequent activities resulted in nearly 100% coverage of the state and timely reporting to the FBI's UCR Program by 1978.

In 1982, the KBI, with the aid of a local law enforcement user's group, began to study the usefulness of establishing an Incident Based Reporting (IBR) system in Kansas. As a result, in 1986, the first Kansas Incident Based Reporting System (KIBRS) was implemented to collect relevant information on the occurrence and composition of crime in Kansas. Pursuant to state statute, law enforcement agencies at state and local levels began reporting standardized data on criminal offenses in their respective jurisdictions using a format approved by the Attorney General. The state program then converted the data to UCR format for submission to the FBI.

Throughout its first 60 years of operation, the FBI's UCR Program remained virtually unchanged in terms of the data collected and disseminated. As time progressed a broad utility evolved for UCR data. This allowed law enforcement to expand its capabilities to supply crime information. In the late-1970's, the law enforcement community called for a thorough evaluative study of UCR with the objective of recommending an expanded and enhanced UCR Program to meet law enforcement needs into the 21st century. The result was the implementation of the National Incident Based Reporting System (NIBRS) in 1988.

In 1991, the KBI, with the aid of a second local law enforcement user's group, began a comparative study of KIBRS against NIBRS. As a result, in 1993, the KBI implemented a new KIBRS program meeting the requirements of NIBRS. This resulted in new standardized forms and created formats for reporting data to the KBI electronically.

Since the arrival of incident based reporting, offense and arrest reports are now being used for much more than annual statistics. The expansion of data fields that are collected will assist Kansas in moving into the future by using these reports to assist in criminal investigations. In addition, IBR data offers:

- (1) More detailed, accurate, and meaningful data than produced by the traditional summary UCR Program;
- (2) Common denominator links among agencies both statewide and nationally;
- (3) Extensive, specific crime information concerning similar jurisdictions, allowing the identification of common crime problems or trends;
- (4) Statistics to enable law enforcement agencies to supply a better accounting of their activities to their governing bodies;
- (5) Legislators, municipal planners / administrators, academicians, penologists, sociologists, and the general public the ability to better assess the state's crime problems using the extensive data supplied through KIBRS;
- (6) Availability of KIBRS data through the Kansas Criminal Justice Information System (KCJIS) web-server.
- (7) Information necessary to acquire funding from grants to combat crime for a law enforcement agency.
- (8) Development of investigative tools to assist law enforcement agencies as they examine cases, leads and other investigations. KIBRS Views and the FBI's National Data Exchange (N-DEX) are two examples of this type of tool.

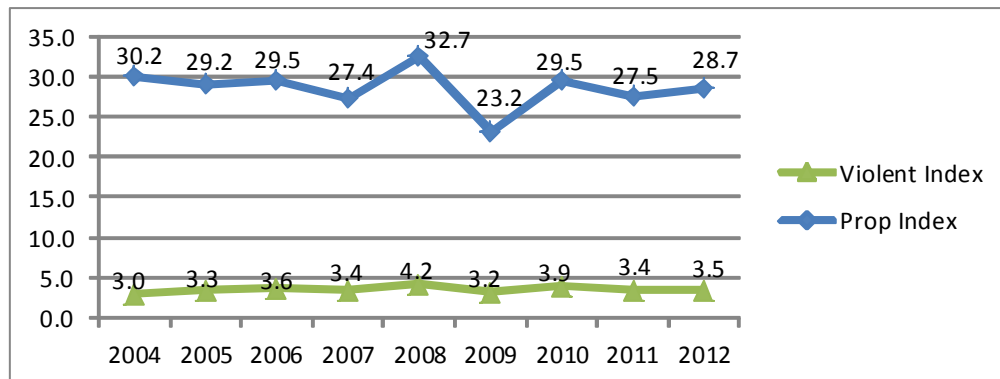

RATE OF INDEX CRIME

Index crimes totaled 75,795 offenses for 2012, consisting of 32 offenses per 1,000 population. This is a slight increase from 31 as reported in 2011.

LARGEST CATEGORY OF INDEX CRIMES

The largest number of offenses reported in 2012 were for larceny (theft) with 49,342 offenses. Property loss for larceny offenses were valued at \$32,663,893. The number of thefts reported increased 5.3% from 2011, with a 16.9% decrease in dollar loss.

VIOLENT CRIMES

There were 8,134 violent crimes (murder, rape, robbery, and aggravated assault/battery) reported in 2012. This increased 2.6% from 2011.

NON-VIOLENT CRIMES

There were 67,661 non-violent crimes (burglary, larceny, and motor vehicle theft) reported in 2012. This increased 4.5% since 2011.

VALUE OF STOLEN PROPERTY

Stolen property was valued at \$77,142,271 in 2012; of that amount 20.0% were recovered. The dollar loss increased by \$10,912,143 or 16.5% compared to 2011.

MURDERS

A total of 54 murders were reported in 2012, down 14.3% from 2011

LAW ENFORCEMENT OFFICERS KILLED OR ASSAULTED

Two officers were killed in 2012 as the result of a felonious act.

No officers were killed in 2012 as the result of an accident or negligent act.

Nine hundred sixty-four (964) law enforcement officers were assaulted in 2012. This represents a increase of 6.3% from 2011.

CRIME CLEARANCE RATE

The clearance rate for all index crimes reported in 2012 was 15.1%; down from the 2011 rate of 15.7%



ARRESTS FOR INDEX CRIMES

A total of 11,217 people were arrested for index crimes, constituting 12.7% of all reported arrests made in 2012. The total was up 0.1% from the 11,202 arrests reported in 2011.

DRUG ABUSE ARRESTS

There were 8,917 arrests for drug abuse violations in 2012. This constituted 10.1% of all reported arrests made in 2012. The total was down 10.1% from the 9,920 arrests reported in 2011.

ALCOHOL RELATED ARRESTS

There were 17,532 alcohol related arrests (DUI, drunkenness, and other liquor law violations) in 2012. These accounted for 19.9% of all arrests for 2012. The total was down 10.3% from the 19,549 alcohol related arrests reported in 2011. Summons or Notice to Appear are counted as arrests.

RATIO OF FULL-TIME LAW ENFORCEMENT EMPLOYEES

In 2012, there were 6,519 full-time sworn law enforcement employees in Kansas. This represents a decrease of 7.6% from 2011. The police employee ratio was 2.3 employees per 1,000 in population. This data includes all agencies reporting data in Kansas.

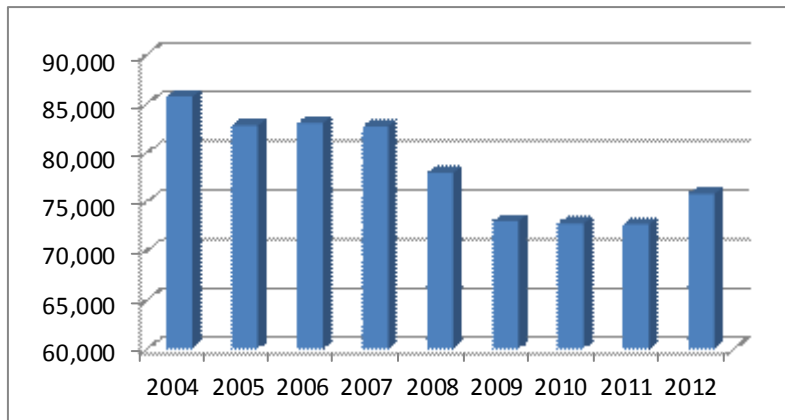
POPULATION

The total number of law enforcement agencies contributing incident based data in 2012 was 347. There were 368 agencies contributing incident based data in 2011.

Total Index Crimes Reported

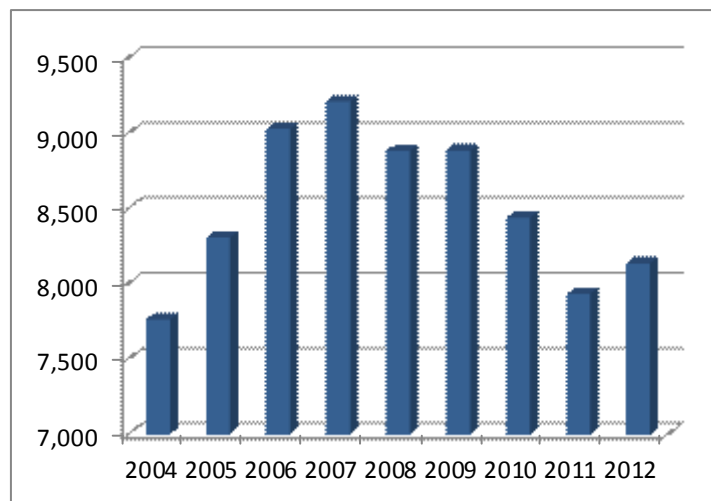

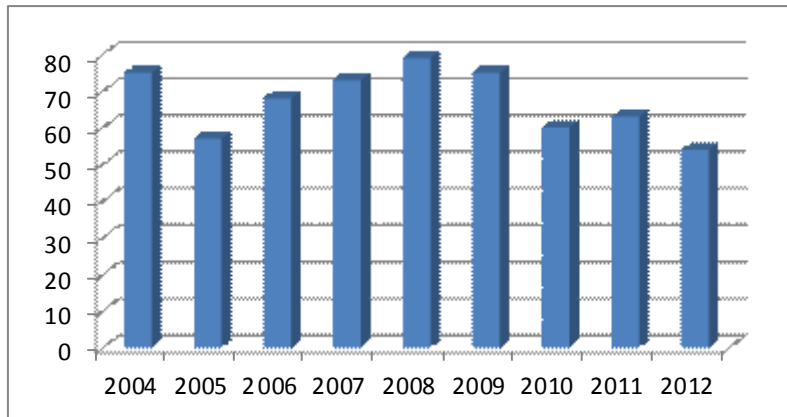

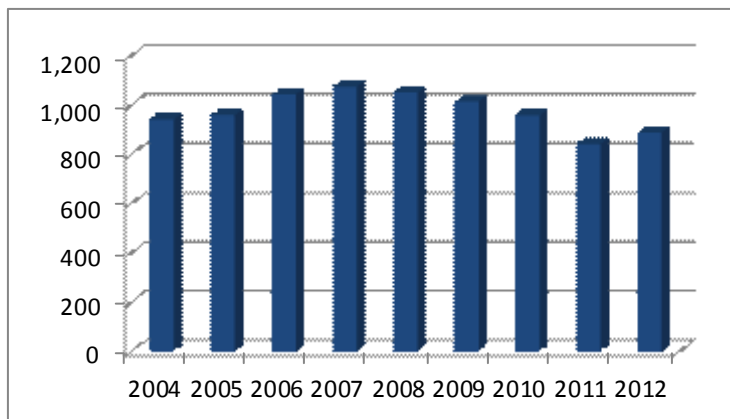

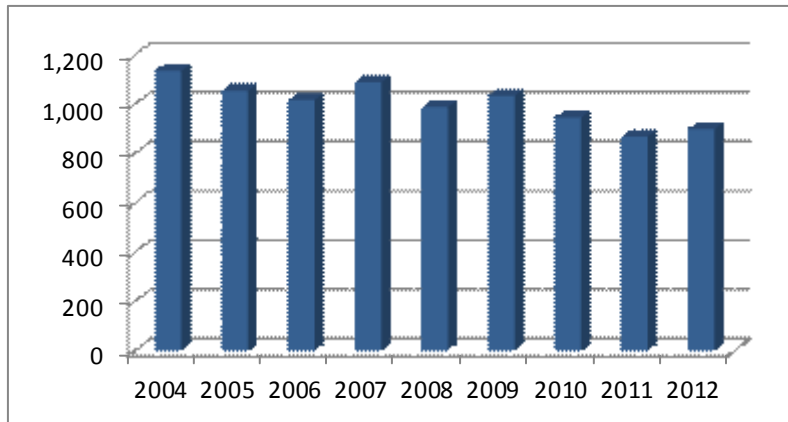

- In the past three years the total number of reported rapes has decreased by 7.3%.

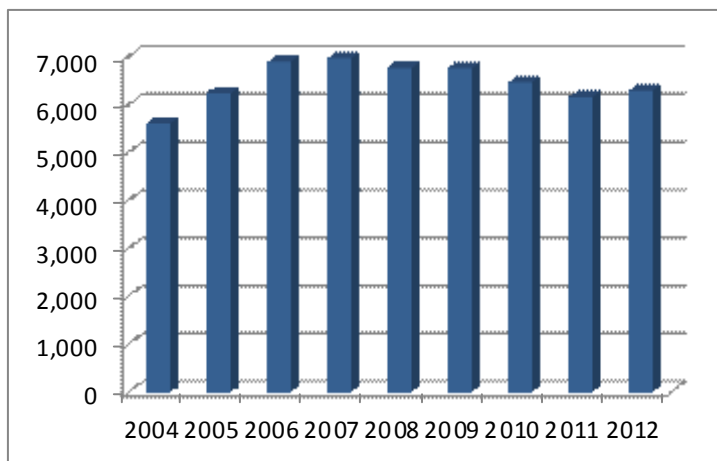

Total Aggravated Assault/Battery Reported

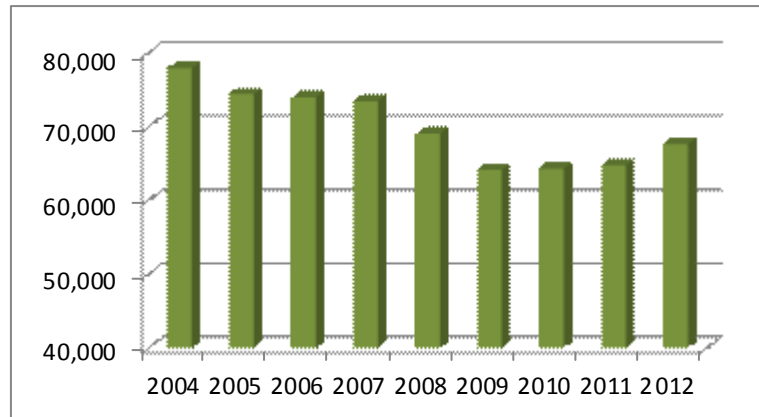

- In the past three years the total number of reported aggravated assault/batteries has decreased by 2.8%.

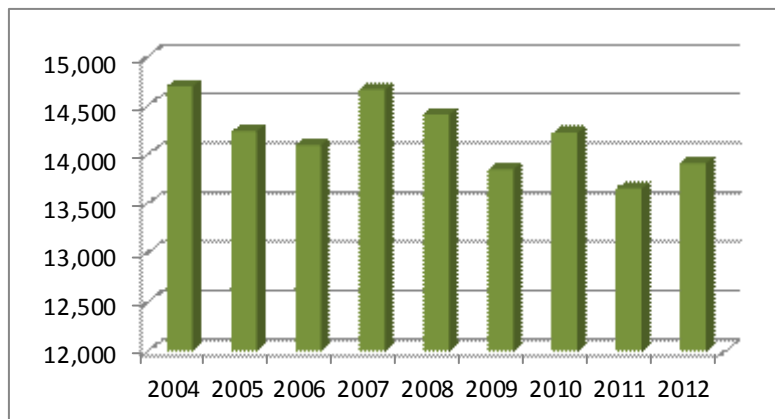

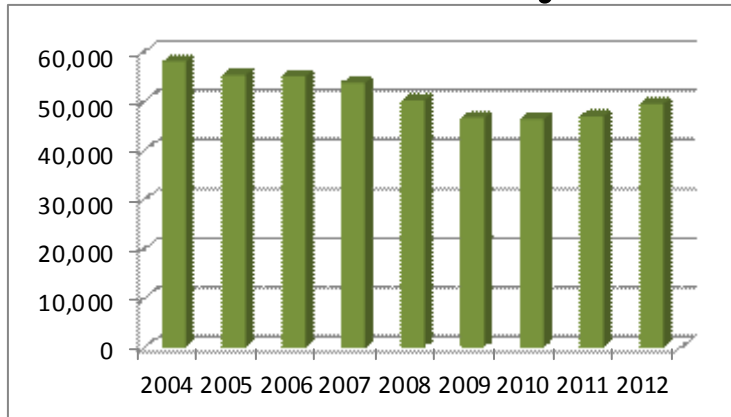

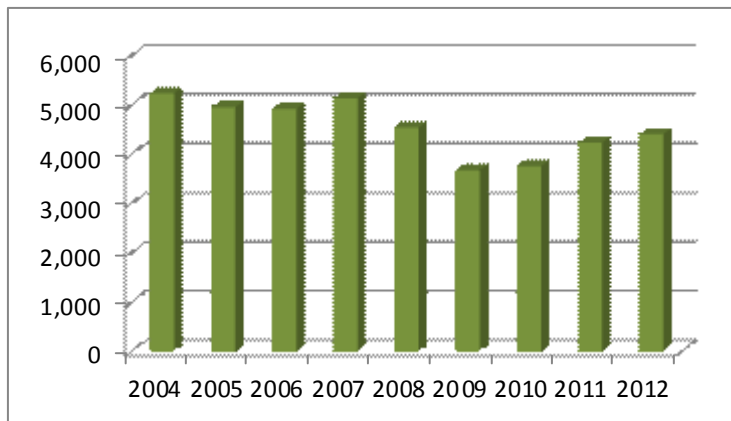

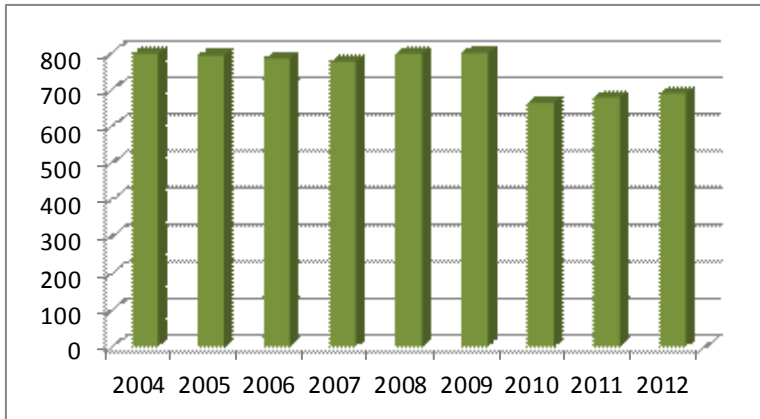

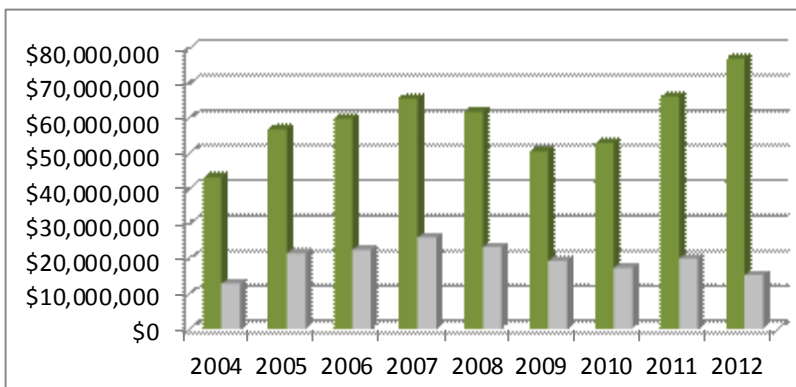

CLASSIFICATION OF INDEX CRIMES

Index crimes are also referred to as Part I crimes. The following list briefly explains each category and the type of offenses that are reported within each index classification.

Murder/Voluntary Homicide: The willful killing of another human being. This does not include homicides deemed to be justifiable.

Forcible Rape: The carnal knowledge of a person, forcibly and / or against that person's will; or where the victim is incapable of giving consent because of his / her temporary or permanent mental or physical incapacity including sexual intercourse with a child under 14 years of age.

Robbery: The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and / or by putting the victim in fear of immediate harm.

Aggravated Assault/Battery: An unlawful attack by one person upon another wherein the offender uses a weapon, or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness. This also includes assault with disease (as in cases when the offender is aware that he / she is infected with a deadly disease and deliberately attempts to inflict the disease by biting, spitting, etc.).

Burglary: The unlawful entry into a building or other structure with the intent to commit a felony, a theft, or a sexual battery.

Larceny/Theft: The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.

Motor Vehicle Theft: The theft of a motor vehicle. A "motor vehicle" is a self-propelled vehicle that runs on the surface of the land and not on rails.

Arson: To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire, explosion or incendiary device.

Summary Analysis of Index Crimes

INDEX CRIME OFFENSES

The following three graphs illustrate the trends of the 2010, 2011, and 2012 total number of offenses by month. This information is based on the Kansas Crime Index.

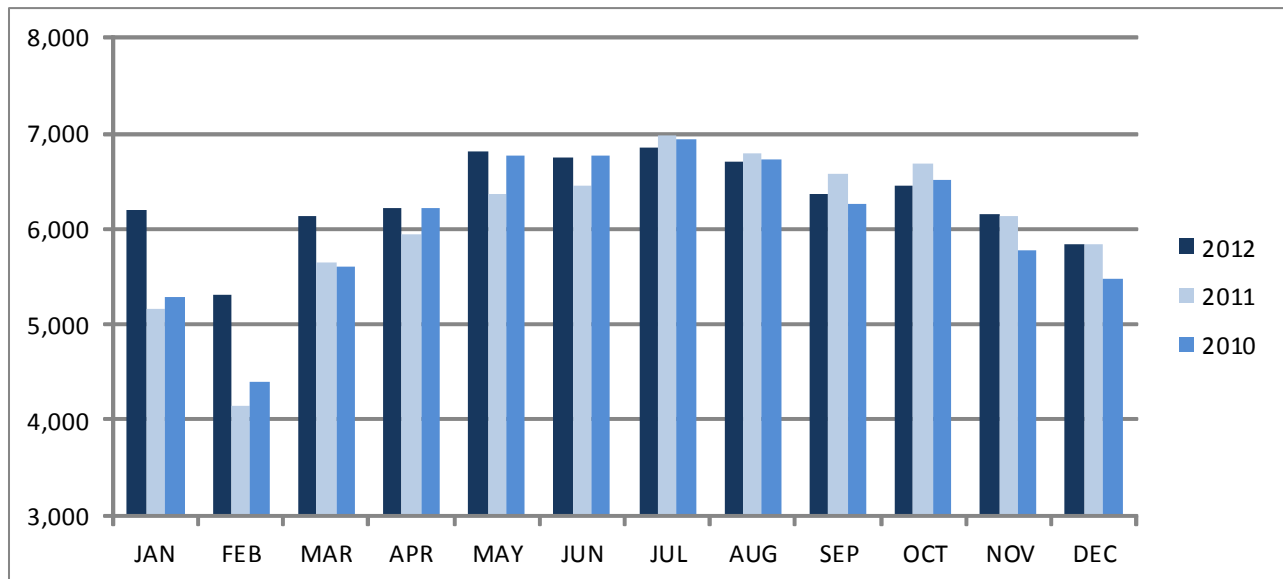
The first graph represents the total number of index offenses occurring each month. The other two illustrate breakdowns of violent crimes and non-violent crimes by month.

SUMMARY ANALYSIS

A total of 75,795 index crimes were reported in 2012. With 6,861 offenses, the month of July reflected the highest number of index crimes reported. The month of February showed the lowest number of reported offenses with 5,316 index crimes.

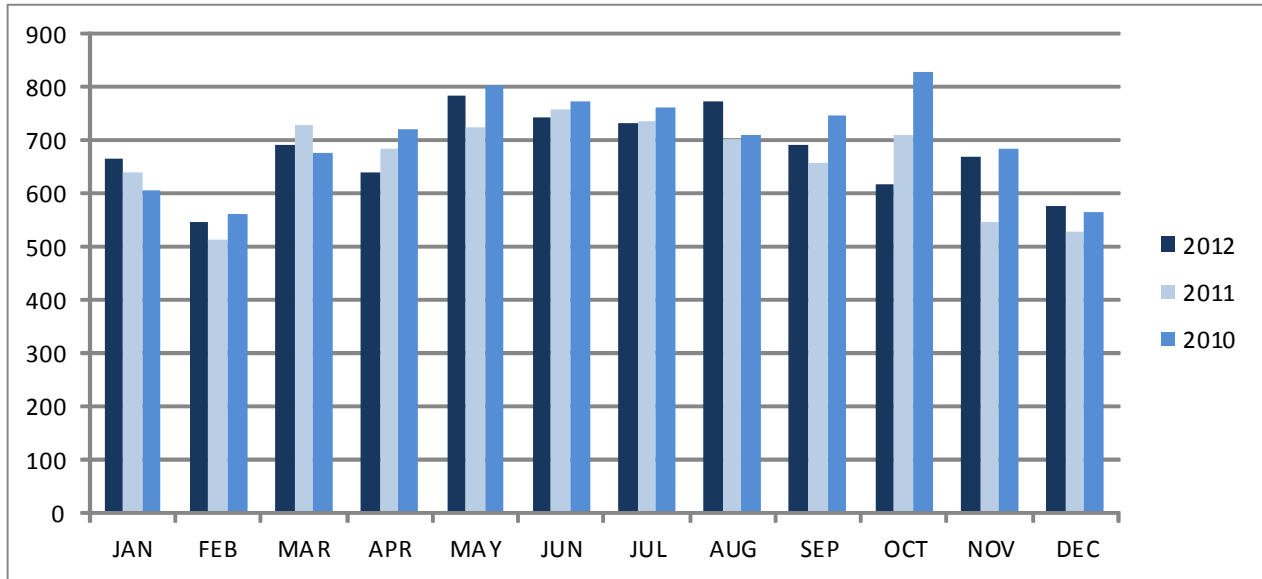
A further breakdown of the 2012 index crime offenses shows May had the greatest number of violent crimes with 784 offenses reported. The lowest number of violent crimes occurred in February with 545 offenses reported. A monthly analysis of the non-violent crimes indicates that July and February showed the highest and lowest number of offenses with monthly totals of 6,129 and 4,771 respectively.

Total Index Crimes By Month



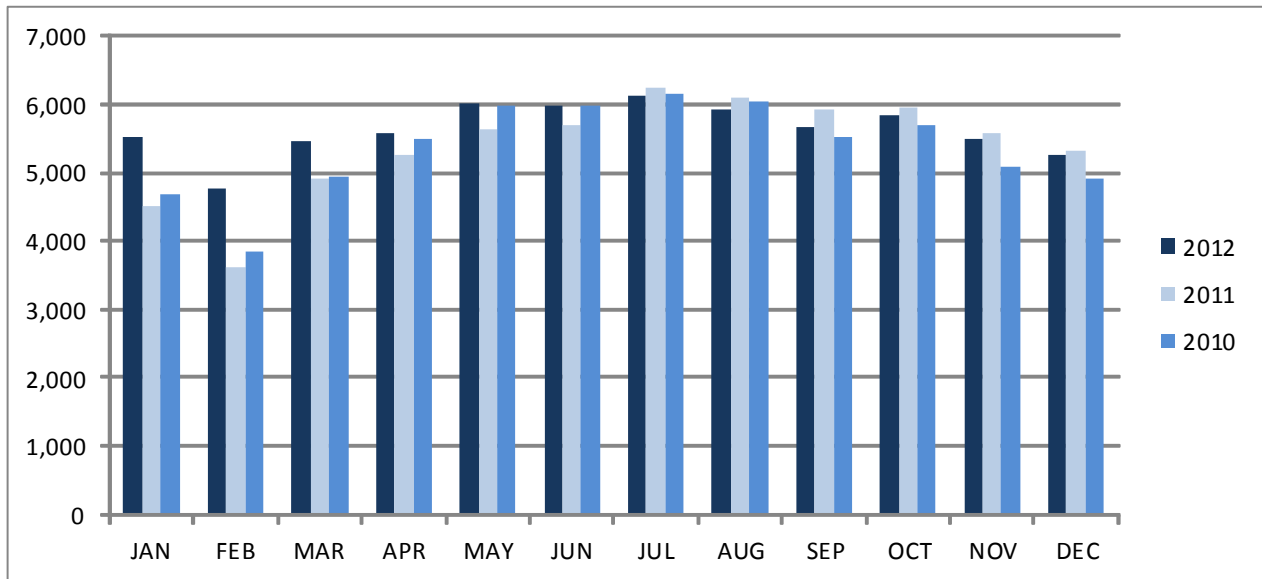

All Index Crimes

- One index crime is reported every 6 minutes and 54 seconds.
- One violent crime is reported every 1 hour 4 minutes and 36 seconds.
- One non-violent crime is reported every 7 minutes and 48 seconds.

Violent Crimes

- One murder is reported every 6 days and 18 hours and 12 seconds.
- One rape is reported every 9 hours and 51 minutes and 54 seconds.
- One robbery is reported every 9 hours 44 minutes and 36 seconds.
- One aggravated assault/battery is reported every 1 hour 23 minutes and 30 seconds.



Property Crimes

- One burglary is reported every 37 minutes and 47 seconds.
- One larceny/theft is reported every 10 minutes and 39 seconds.
- One motor vehicle theft is reported every 1 hour 59 minutes and 18 seconds.
- One arson is reported every 12 hours and 42 minutes and 48 seconds.



These crime clocks should be viewed with care. Being the most aggregate representation of crime data, it is designed to convey the annual crime experience by showing the relative frequency of occurrence of crime incident. This mode of display should not be taken to imply a regularity in the commission of these incidents; rather, it represents the annual ratio of crime to fixed time intervals.

Murder/Voluntary Manslaughter

DEFINITION: The unlawful killing of a human being with malice and aforethought.

Any death due to an argument, fight, assault or commission of a crime. This crime is classified based on the investigation of law enforcement and does not include findings of a prosecutor or court. Involuntary manslaughter, suicide, accidental death and justifiable homicide are not counted in this category.

Attempted murders are classified as Aggravated Assault/Battery and not Murder.

SUMMARY

54 murders were reported by law enforcement in 2012.

Murders accounted for 0.7% of all violent index crimes.

52 murders were cleared by either an arrest or death of the offender with a clearance rate of 96.3%.

51.9% of the murders committed in 2012 involved the use of firearms. Knives/Cutting Instruments were 16.7% and Personal Weapons (Hands, Fists, Feet) consisted of 11.1%.

Domestic Violence (DV) Murder: 24 of the murders reported in 2012 were flagged as DV.

The most common relationship of the victim to the offender for homicides in 2012 was Stranger at 23.7% followed by Acquaintance at 18.4%. However, when looking at known vs. unknown relationships the victim knew the offender in 65.8% of the cases.

Victim Characteristics:

The most common age group of murder victims in 2012 were 30-39 year olds. They made up 29.6% of all homicides. The 20-29 year old group followed with 25.9%. As a percentage, 30-39 year olds have seen the largest 3 year increase.

Males accounted for 70.4% of homicide victims while females made up 29.6%.

Racial breakdowns for murder victims were: White 68.5%, Black 25.9%, Asian 5.6%. Hispanic ethnicity was listed in 7.4% of the victims reported.

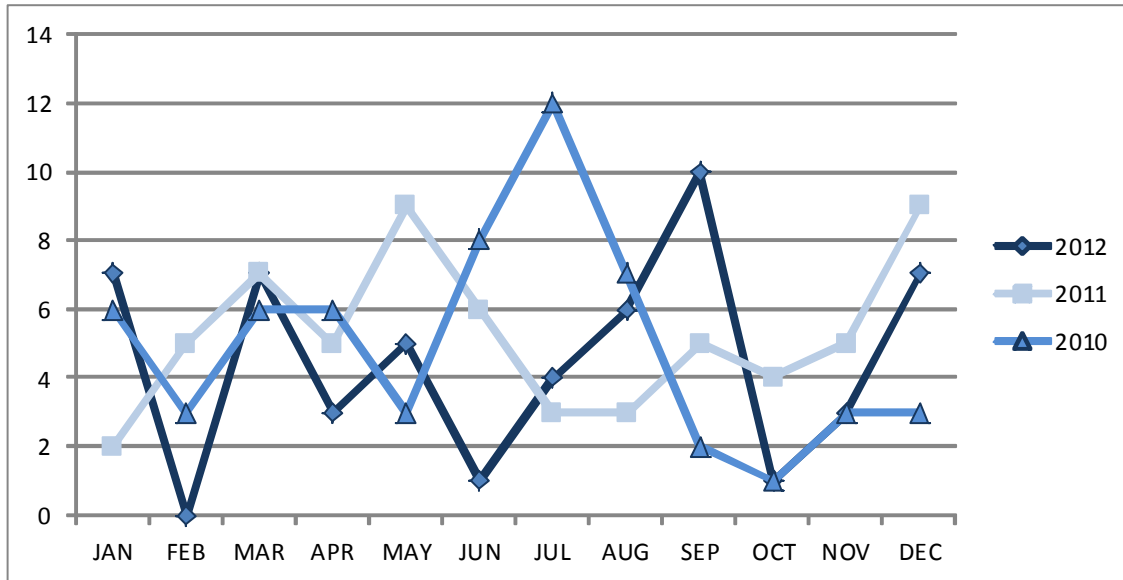
Suspect Characteristics:

The most common age group of murder suspects in 2012 were 20-29 year-olds. They made up 40.5% of all murder suspects. The 30-39 year old group followed with 22.9%.

Males accounted for 85.1% of murder suspects while females made up 13.5%.

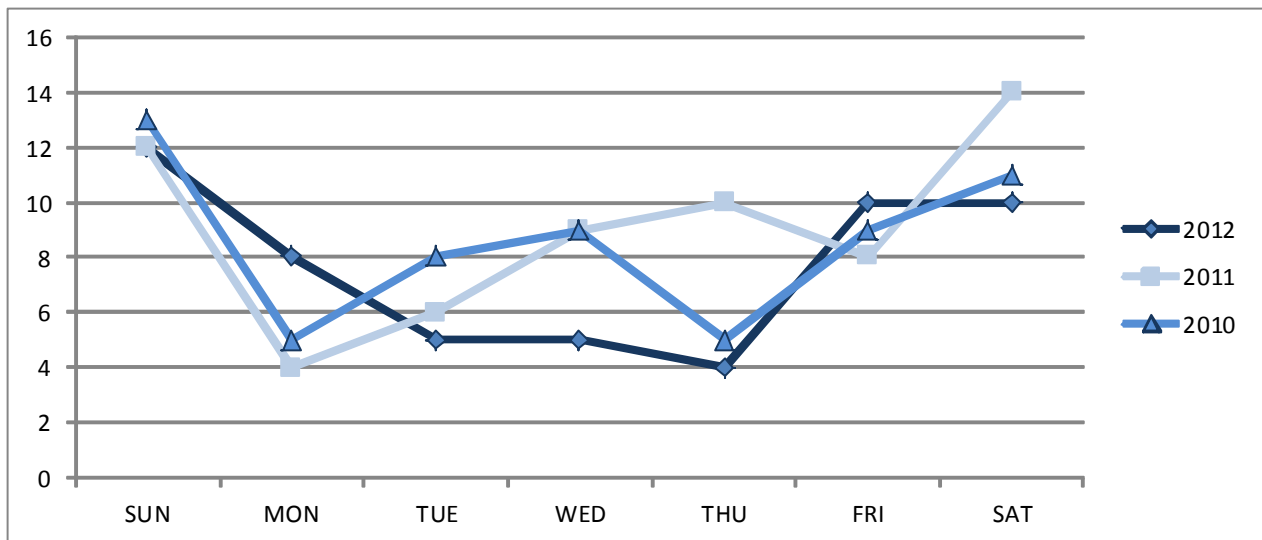

Forcible Rape

DEFINITION: The carnal knowledge of a person, forcibly and / or against that person's will; or where the victim is incapable of giving consent because of his / her temporary or permanent mental or physical incapacity including sexual intercourse with a child under 14 years of age.

SUMMARY

888 rapes were reported by law enforcement in 2012.

Rapes accounted for 10.9% of all violent index crimes and 1.2% of all index crimes reported in 2012.

245 rapes were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 27.6%.

89.5% of the rapes committed in 2012 involved the use of personal weapons (hands, fists, feet). Firearms and knives combined for less than 1.3%

Rapes occurred most often, 78.5%, in a residence. While 11.3% were in a public area, and 6.6% occurred at a business.

The most common relationship of the victim to the offender for rapes in 2012 was acquaintance at 25.6%, followed by unknown at 12.5%. In 75.4% of the cases, the offender was known to the victim.

Victim Characteristics:

The most common age group of rape victims in 2012 were 10-19 year olds. They made up 44.8% of all rapes. The 20-29 year old group followed with 24.8%.

Females accounted for 98.0% of rape victims. (In Kansas, males can be victims of rape if they are under the age of 14).

Racial breakdowns for rape victims were: White 86.9%, Black 10.6%, Asian 1.0%, Native Indian 0.8%, Unknown 0.7%. Hispanic ethnicity was listed in 10.9% of the victims reported.

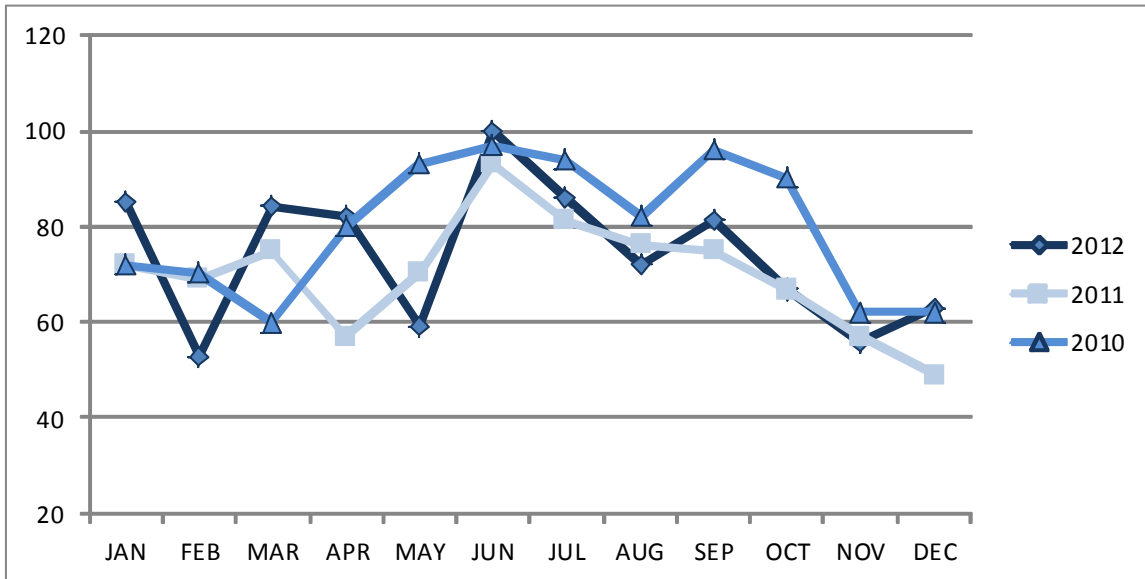

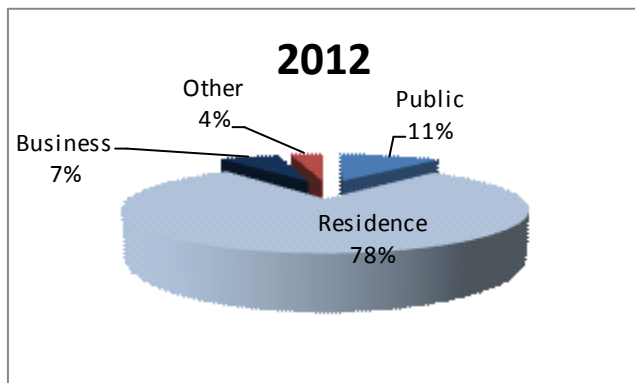

Robbery

DEFINITION: The taking, or attempting to take, anything of value under confrontational circumstances from the control, custody, or care of another person by force or threat of force or violence and / or by putting the victim in fear of immediate harm.

SUMMARY

899 robberies were reported by law enforcement in 2012.

Robberies accounted for 11.1% of all violent index crimes and 1.2% of all index crimes.

239 robberies were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 26.6%.

39.8% of the robberies committed in 2012 involved the use of personal weapons (hands, fists, feet). Firearms and knives represented 36.3% and 10.9% respectively.

Robberies are evenly distributed between residence (35.4%), public (33.7%), business (28.5%) and other (2.4%)

The property loss attributed to robberies in 2012 amounted to \$825,250 which was a decrease of 26.4% from the over \$1.1 million dollars reported in 2011. Cash accounted for 42.6% of total property loss followed by vehicles at 29.5%.

Victim Characteristics:

Victims can be individuals or businesses. By definition, at least one victim in each incident must be an individual.

The most common age group of individual robbery victims in 2012 were 20-29 year olds. They made up 33.9% of all robberies.

Males accounted for 60.8% of individual robbery victims.

Racial breakdowns for robbery victims were: White 77.9%, Black 17.1%, Asian 1.9%, Native Indian 0.7% and Unknown 2.3%. Hispanic ethnicity was reported in 12.6% of the victims reported.

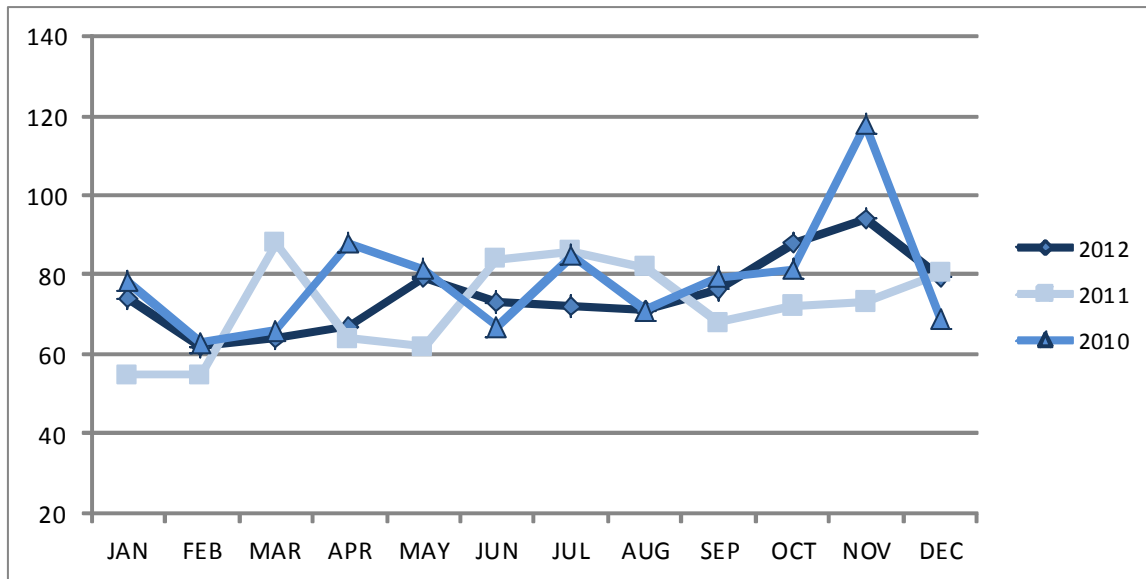

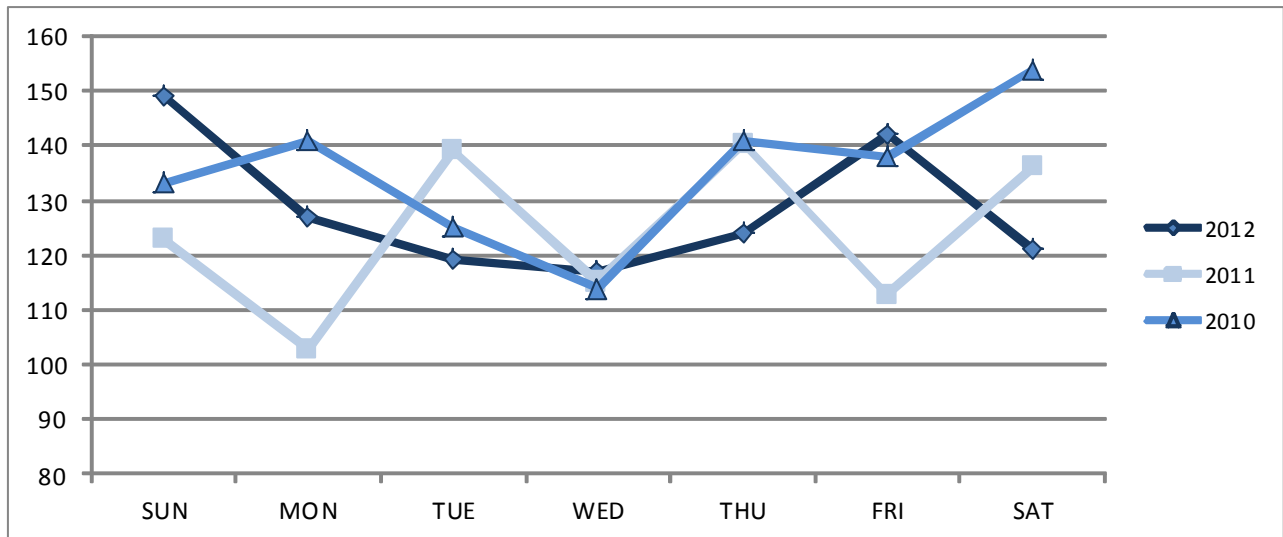

Aggravated Assault/Battery

DEFINITION: An unlawful attack by one person upon another wherein the offender uses a weapon, or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.

SUMMARY

6,293 aggravated assaults/battery were reported by law enforcement in 2012.

Aggravated assaults/battery accounted for 77.4% of all violent index crimes and 8.3% of all index crimes.

2,540 aggravated assaults/battery were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 40.4%.

26.4% of the aggravated assaults/battery committed in 2012 involved the use of Personal Weapons (Hands, Fists, Feet). Firearms and Knives represented 22.8% and 18.9% respectively.

Aggravated assaults/battery occurred most often in a residence, 59.9%, while 25.1% were in a public area, and 10.6% occurred at a business.

The most common relationship of the victim to the offender for aggravated assaults/battery in 2012 was Stranger at 16.9%, followed by Acquaintance at 16.8%. In 70.2% of the cases, the victim knew the offender.

Victim Characteristics:

The most common age group of aggravated assaults/battery victims in 2012 were 20-29 year olds. They made up 29.6% of all aggravated assault/battery victims.

Males accounted for 60.7% of aggravated assaults/battery victims.

Racial breakdowns for aggravated assault/battery victims were: White 78.0%, Black 19.1%, Asian 0.8%, Native Indian 0.6% and Unknown 1.4%. Hispanic ethnicity was reported in 11.8% of the victims reported.

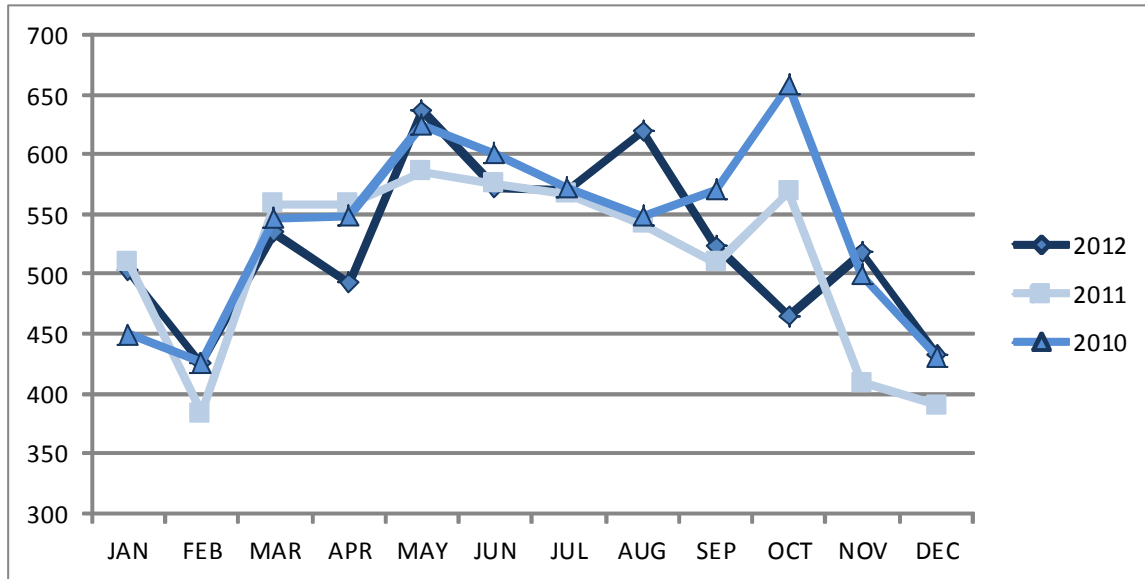

Burglary

DEFINITION: The unlawful entry into a building or other structure with the intent to commit a felony, a theft, or a sexual battery.

SUMMARY

13,912 burglaries were reported by law enforcement in 2012

Burglaries accounted for 22.1% of all property index crimes and 19.8% of all index crimes.

1,106 burglaries were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 8.0%.

Burglaries occurred most frequently at a residence (71.3%), followed by business (17.7%).

The property loss attributed to burglaries in 2012 amounted to \$29,040,639 which was a decrease of 1.5% from almost \$29.5 million dollars reported in 2011. Jewelry/Precious Metals accounted for 21.7% of total property loss followed by Electronics at 16.1%.

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 85.3%; Businesses 12.2%; Government 1.4%; Others 0.9%; and Financial 0.2%

The most common age group of individual burglary victims in 2012 were 20-29 year olds. They made up 22.7% of all burglaries.

Males accounted for 57.1% of individual burglary victims. Females were 42.4%.

Racial breakdowns for burglary victims were: White 88.6%, Black 8.5%, Asian 1.3%, Native Indian 0.3% and Unknown 1.3%. Hispanic ethnicity was listed in 8.1% of the victims reported.

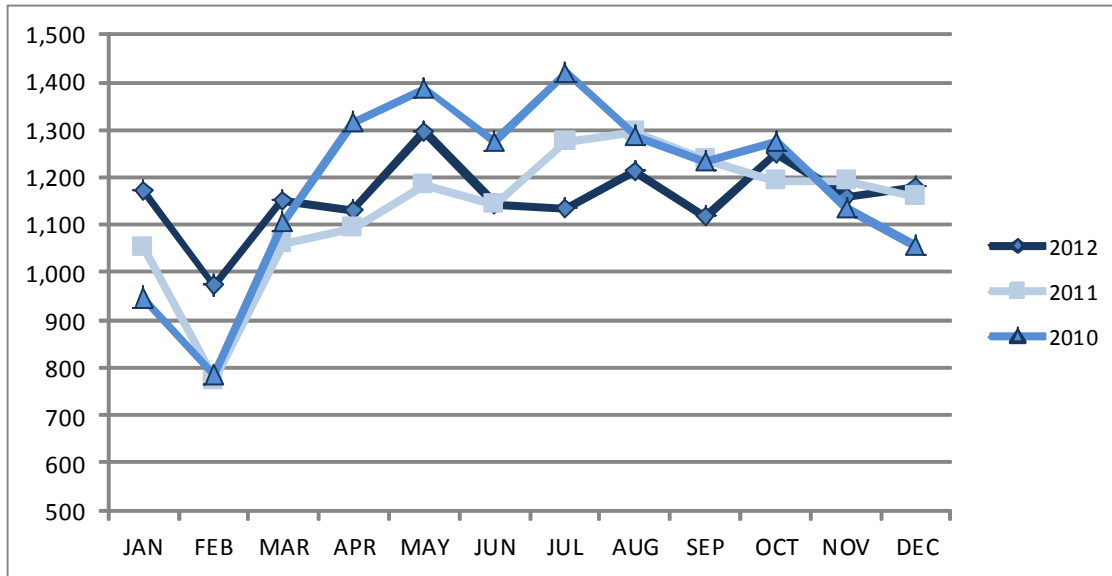
Suspect Characteristics:

The most common age group of burglary suspects in 2012 were Unknowns at 68.5%. They were followed by 20-29 year olds at 11.2% of all burglary suspects.

Males accounted for 29.0% of burglary suspects, females 6.4% and unknowns made up 64.7%.

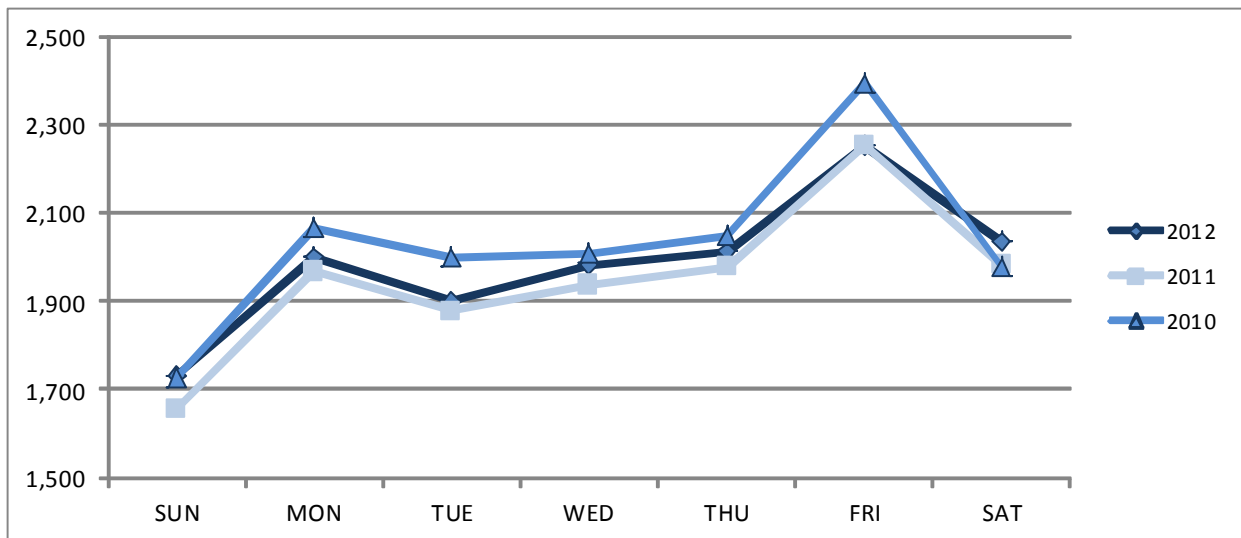

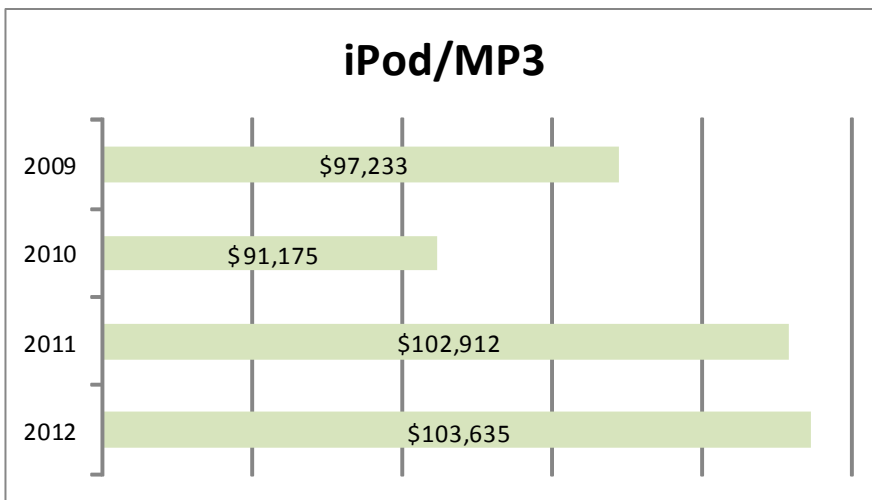
Burglary Offenses: Property Loss Trends



- While copper thefts have been on the rise for several years., 2012 did see a decline in the value stolen in burglaries
- 2012 saw a 42% decrease in the value of copper reported stolen during a burglary.
- Since 2009, the increase in reported copper values was 409%.



- An increase in the value of cell phones led to a 170% increase in stolen property value since 2009.
- 2012 saw a 54% increase in value of cell phones stolen in burglaries.



- Values of iPod and Mp3 players stolen in burglaries has historically increased each year.
- While 2010 reversed that trend with a 6.2% drop, 2011 and 2012 saw an increase in property value.
- Since 2009 the value of stolen iPod and MP3 players has increased 6.6%

Larceny/Theft

DEFINITION: The unlawful taking, carrying, leading, or riding away of property from the possession, or constructive possession, of another person.

SUMMARY

49,342 larcenies were reported by law enforcement in 2012.

Larcenies accounted for 55.0% of all property index crimes and 49.1% of all index crimes.

7,241 larcenies were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 14.7%.

Larcenies occurred most frequently at a business (42.8%), followed by residence (41.2%).

The property loss attributed to larcenies in 2012 amounted to \$32,713,033 which was a decrease of 16.8% from the over \$39.0 million dollars reported in 2011. Miscellaneous accounted for 18.8% of total property loss followed by Jewelry/Precious Metals at 16.1%. Copper thefts accounted for 25.2% of jewelry/precious metal thefts.

All Other Theft made up 31.1% of theft types followed by Theft from a Motor Vehicle at 23.3%.

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 69.4%; Businesses 27.8%; Government 2.0%; Others 0.4%.

The most common age group of individual larceny victims in 2012 were 20-29 year olds. They made up 24.2% of all larcenies.

Males accounted for 51.9% of individual larceny victims. Females were 47.9%.

Racial breakdowns for larceny victims were: White 89.7%, Black 7.7%, Asian 1.2%, Native Indian 0.5% and Unknown 0.9%. Hispanic ethnicity was reported in 7.2% of the victims reported.

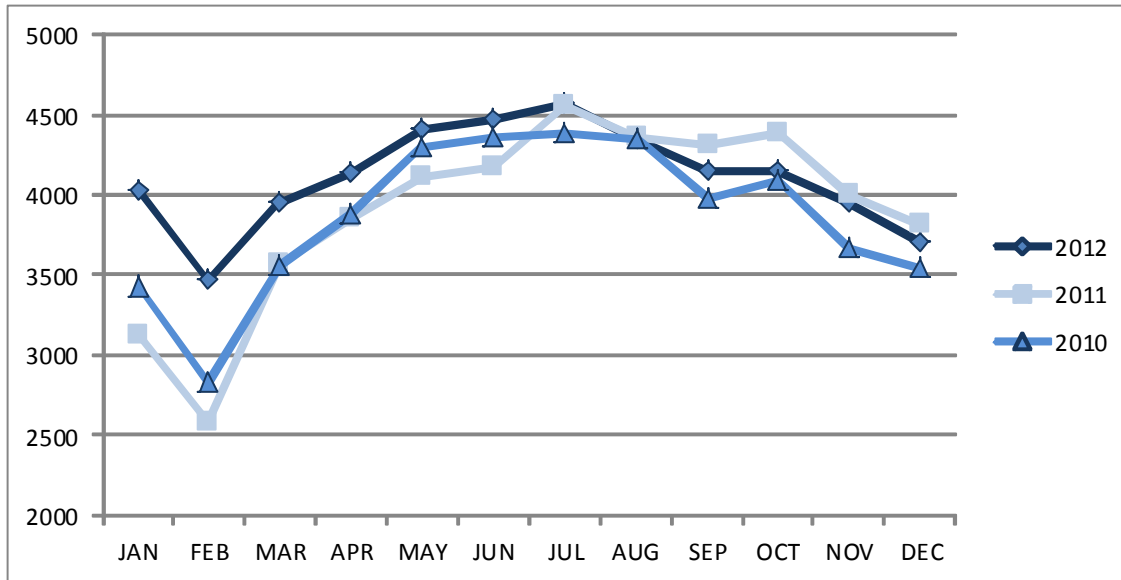

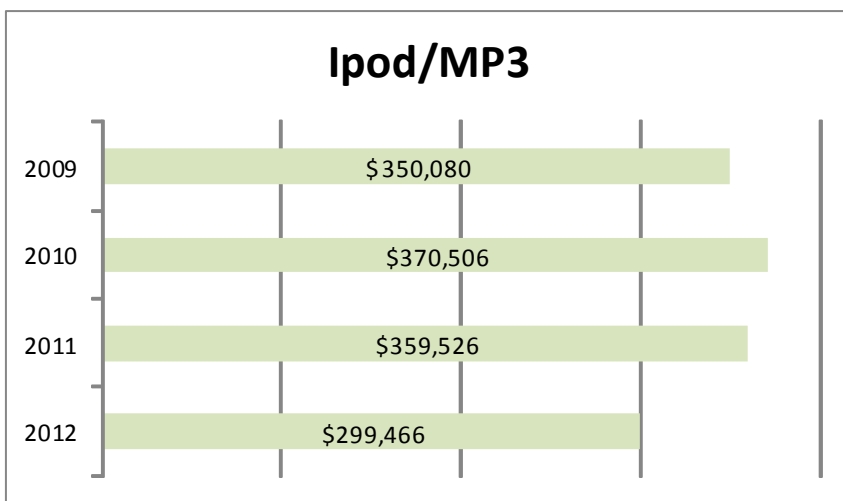
Larceny Offenses: Property Loss Trending



- Copper thefts have increased for several years.
- 2011 saw a 775% increase in the value of copper reported stolen compared to 2010.
- 2012 saw a 80.6% drop from 2011 but still remained higher than previous years
- Since 2009, the increase in reported copper values stolen was 601.5%.



- An increase in the value of cell phones led to a 80.6% increase in property value between 2009 and 2012.
- 2012 saw a 21.9% increase in value of cell phones stolen in larcenies as compared to 2011.



- Values of I-Pod and Mp3 players stolen in larcenies have historically increased each year.
- 2011 and 2012 reversed that trend with a 3.0% drop in 2011 and 16.7% drop in 2012. This is most likely associated with reductions in the cost of these items.

Motor Vehicle Theft

DEFINITION: The theft of a motor vehicle. A “motor vehicle” is a self-propelled vehicle that runs on the surface of the land and not on rails.

SUMMARY

4,407 motor vehicle thefts were reported by law enforcement in 2012 with a value of \$26,432,428. This was an increase of 3.9% in incidents and 3.2% in value from 2011.

Motor vehicle thefts accounted for 6.2% of all property index crimes and 5.6% of all index crimes.

585 motor vehicle thefts were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 13.3%.

Motor vehicle thefts occurred most frequently at a residence (58.6%), followed by business (21.2%).

Automobiles made up 61.9% of the motor vehicle thefts in 2012 followed by Trucks (pick-up) (19.9%), and Motorcycles (10.8%).

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 89.7%; Businesses 9.3%; Other 1.0%

The most common age group of individual motor vehicle theft victims in 2012 were 20-29 year olds. They made up 25.1% of all motor vehicle thefts.

Males accounted for 62.6% of individual motor vehicle theft victims. Females were 37.0%.

Racial breakdowns for motor vehicle theft victims were: White 87.5%, Black 9.7%, Asian 1.5%, Native Indian 0.3% and Unknown 1.0%. Hispanic ethnicity was reported in 10.6% of the victims reported.

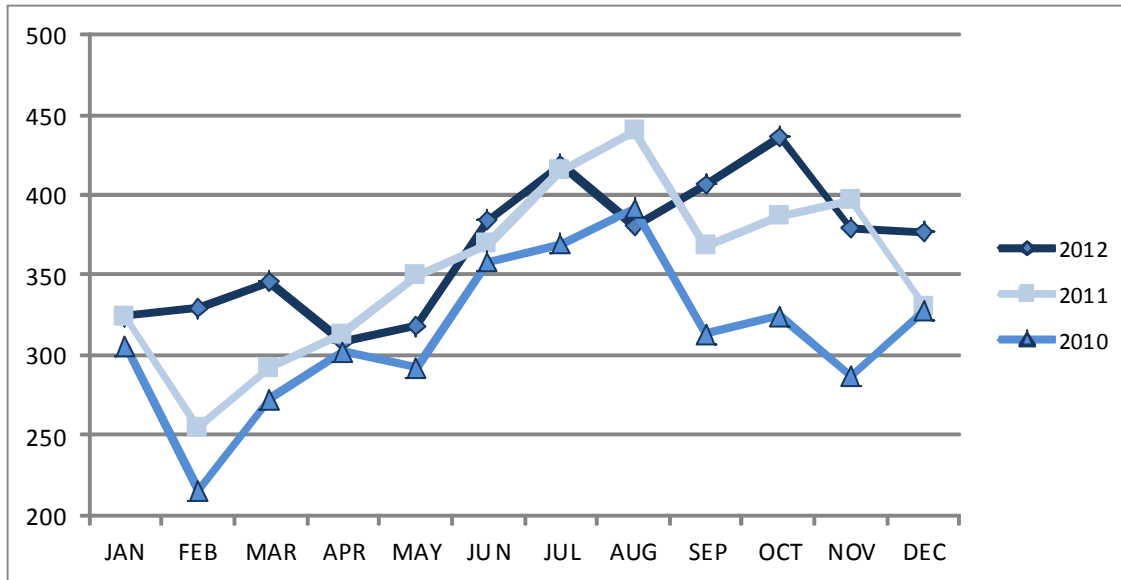
Suspect Characteristics:

The most common age group of motor vehicle theft suspects in 2012 were Unknowns at 59.3%. They were followed by 20-29 year olds at 14.1% of all motor vehicle theft suspects.

Males accounted for 34.7% of motor vehicle suspects, females 10.7% and unknowns made up 54.6%.

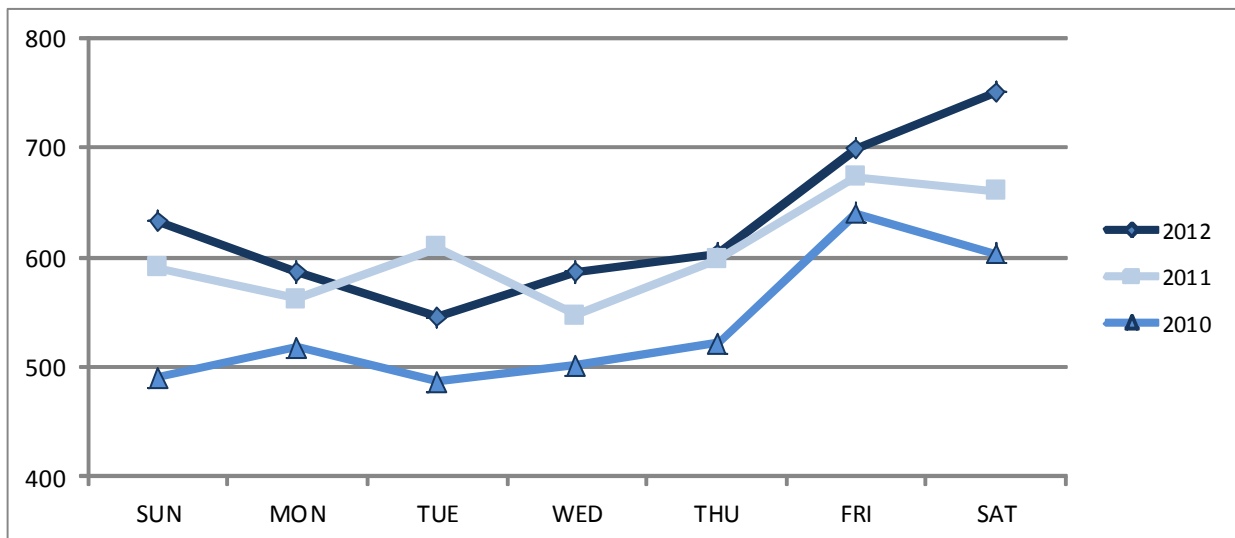

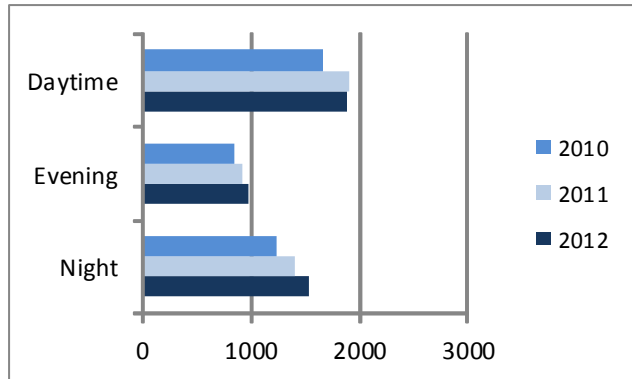
Motor Vehicle Thefts By Day of the Week



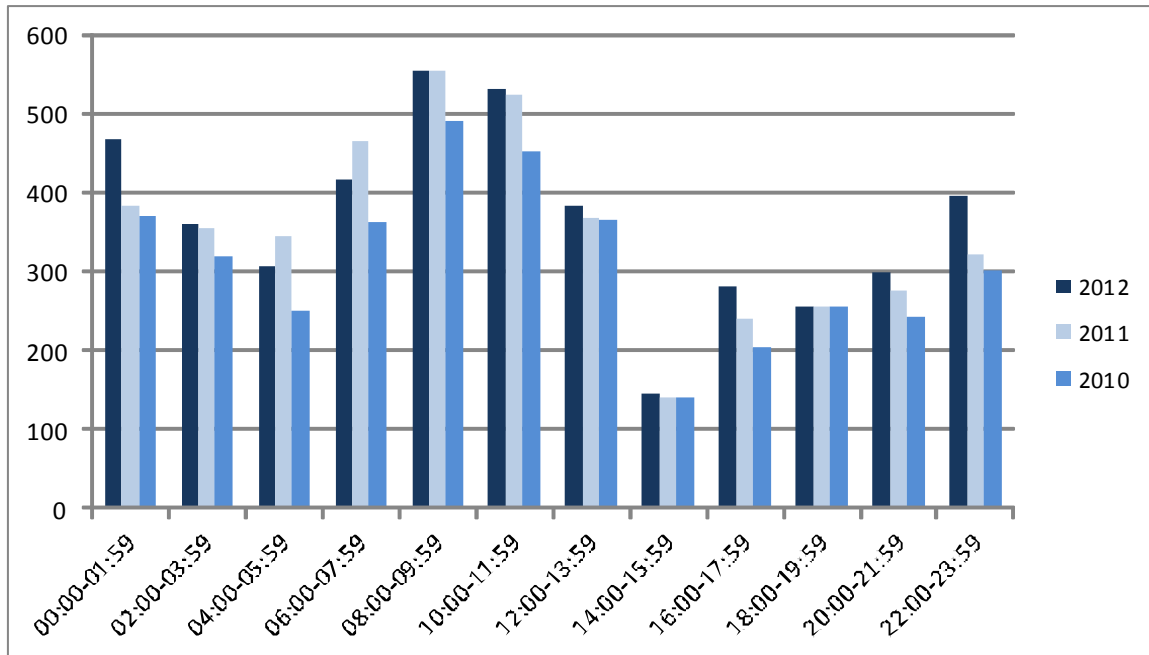
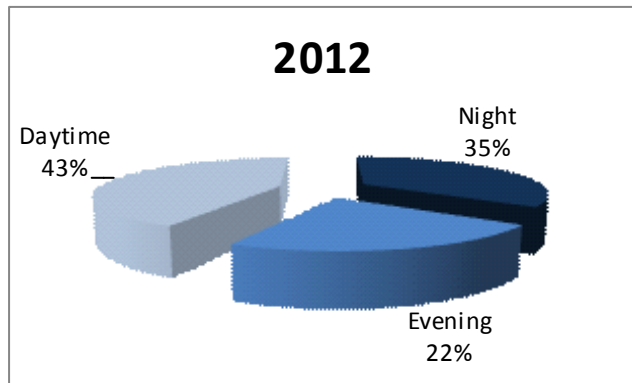

Motor Vehicle Theft Suspect: Age, Sex, Race



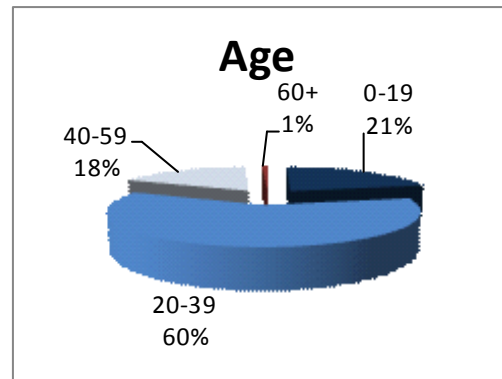
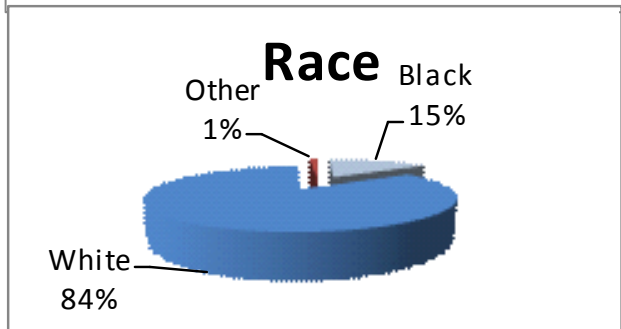
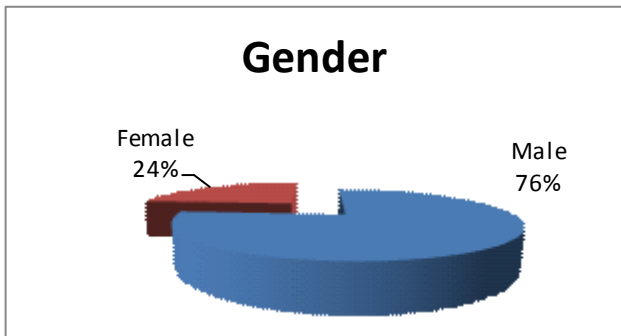

Arson

DEFINITION: To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire, explosion or incendiary device.

SUMMARY

689 arsons were reported by law enforcement in 2012 with a value of \$5,703,272. This was an increase of 1.6% in incidents and a decrease of 24.0% in value from 2011.

Arsons accounted for 1.0% of all property index crimes and 0.9% of all index crimes.

74 arsons were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 10.7%.

Arsons occurred most frequently at a residence (48.5%), followed by public place (34.8%).

Single Occupancy Dwellings made up 48.5% of the arsons in 2012 followed by Other Dwelling (19.1%), and Other Structure (15.7%).

Structures accounted for 69.6% of the arsons reported in 2012 followed by Vehicles 20.8% and Miscellaneous at 3.9%.

Victim Characteristics:

Victims can be individuals, financial organizations, government, religious organizations or businesses. Individuals made up 73.3%; Businesses 11.9%; Government 12.1%.

The most common age group of individual arson victims in 2012 were 20-29 year olds. They made up 21.2% of arsons.

Males accounted for 61.9% of individual arson victims. Females were 37.0%.

Racial breakdowns for arson victims were: White 82.6%, Black 12.5%, Asian 2.5%, Native Indian 0.2% and Unknown 1.1%. Hispanic ethnicity was reported in 11.1% of the victims reported.

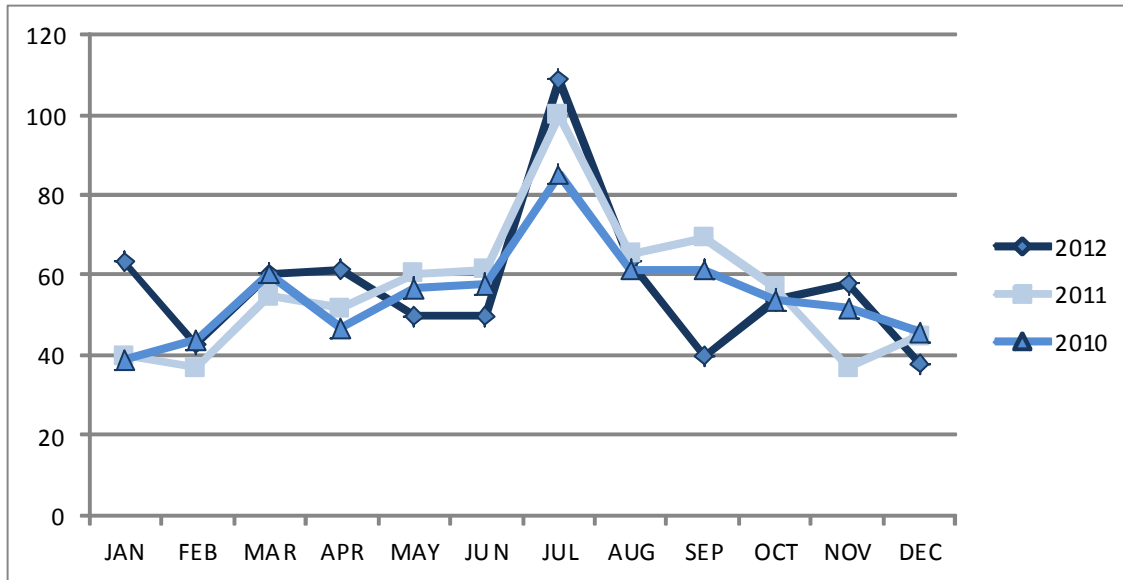

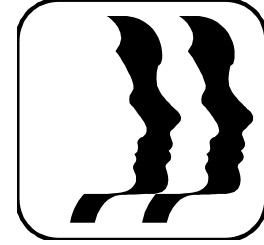

Arson Suspect: Age, Sex, Race



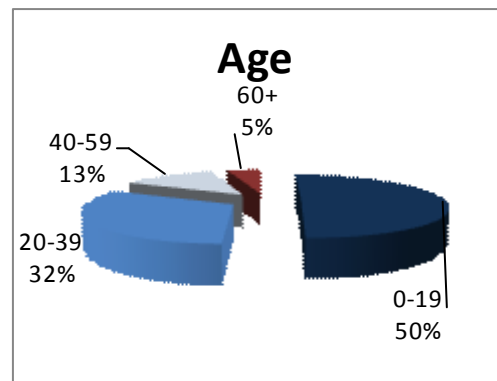
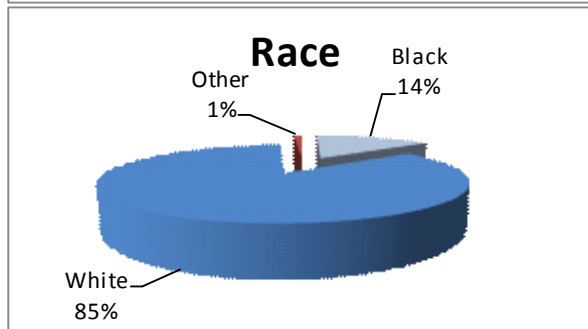
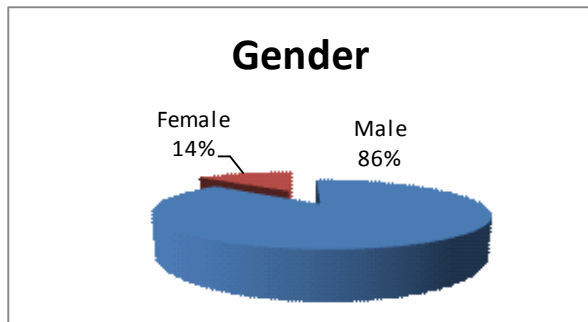

Drug Offenses

DEFINITION: The unlawful cultivation, manufacture, distribution, sale, purchase, use, possession, transportation, or importation of any controlled substance or narcotic drug.

SUMMARY

11,944 drug offenses were reported by law enforcement in 2012. This was a decrease of 0.4% in incidents from 2011.

Drug offenses include illegal possession, sale or manufacture of any controlled substance or narcotics.

7,514 drug offenses were cleared by either an arrest, death of the offender, or refusal by county attorney to prosecute. This shows a clearance rate of 62.9%.

Drug offenses occurred most frequently at a public place (55.3%), followed by residence (25.6%). With the most common being a city street.

Marijuana was most often cited drug seized at 57.1% down from 61.8% in 2011. It was followed by Methamphetamines at 16.2% up from 12.6% in 2011

March saw the most reported drug offenses while Friday was the most reported day of the week. Offenses were evenly spread throughout the day with daytime hours showing the highest number reported.

Victim Characteristics:

Since drug offenses are a society crime, there are no victims reported.

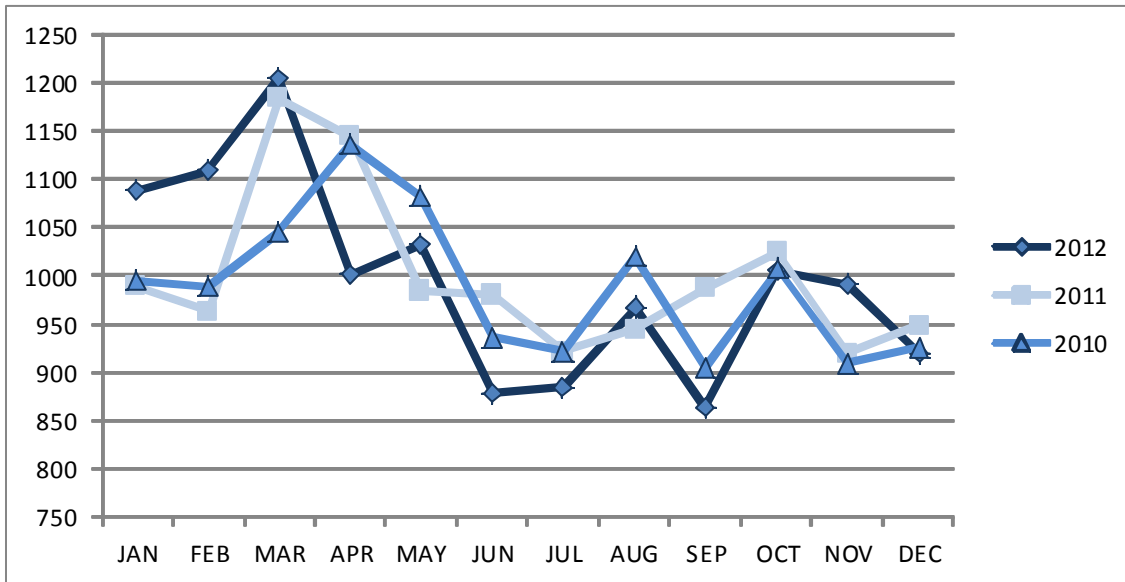
Suspect Characteristics:

The most common age group of drug offense suspects in 2012 were 20-29 year olds at 39.8%. They were followed by 10-19 year olds at 25.6% of all drug suspects.

Males accounted for 75.2% of drug suspects, females 24.4%.

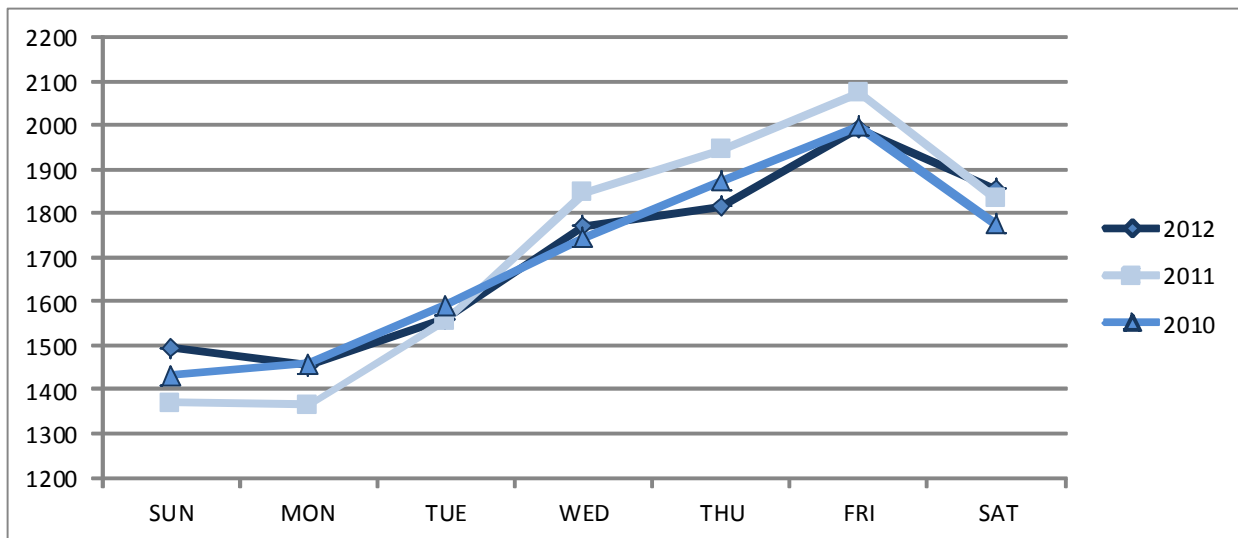
